### 3. DESCRIPTION

ROBERTS 8015 is a universal solvent-free carpet seam sealer developed for seaming most types of carpets, including vinyl-backed and to prevent edge raveling. May also be used to repair bubbles in existing installations.

#### Features and Benefits

- Fast drying, solvent-free formula
- Suitable for all types of carpet, including vinyl-backed carpets
- UV tracers for detection with UV light sources
- Can be used on both direct and double bond installs

#### Uses

For seaming carpet edges and to prevent edge raveling on polypropylene, jute, urethane latex and unitary carpets.

This product is not recommended for seaming vinyl flooring.

#### Coverage

Up to 200 lineal meters per 946 mL / 660 lineal feet per quart.

#### Limitations

- Be careful not to get sealer on carpet nap.
- Ensure adequate ventilation during flooring installation.

<b>Storage:</b>	Protect from freezing. Does not require thinning.

### 5. INSTRUCTIONS

#### Preparation

Ensure substrate, carpet and adhesive are fully acclimated prior to installation at the same temperature and humidity level expected during normal use (65-95°F) with < 65% relative humidity.

#### Installation

Prepare/cut carpet edges according to manufacturer's recommendations. Apply a 1/8" bead of adhesive to one side of the carpet along the backing and where the face yarns enter the backing (not the cushion). Smooth out any excess adhesive. Join the carpet seams while the sealer is still wet.

#### Bubble Repair

Inject or open and spread this product under isolated bubbles of flooring. Roll flooring to receive transfer and sandbag overnight.

#### Curing

Up to 12-24 hours. High temperature and low humidity will cause the adhesive to cure faster.

#### Clean-up

Within 10 minutes after seaming carpet use mineral spirits sparingly with a clean, white cotton cloth.

DO NOT POUR CLEANER DIRECTLY ONTO FLOORING.
