

Cable Guides Snap-Together Cable Guides for Customizable Radiant-Heated Floors



DESCRIPTION

Mapeheat Cable Guides are used to secure *Mapeheat Cable* to a substrate before installation of floor-covering materials (tile, stone, laminate, engineered wood or luxury vinyl flooring). *Mapeheat Cable Guides* can be attached to a wooden subfloor with nails or screws, and to a concrete subfloor with hot glue.

Installing *Mapeheat Cable* with *Mapeheat Cable Guides* offers flexible spacing for varying watt density as follows:

- Consistent 3" (7.5 cm) spacing produces 12 W/ft² (standard output).
- Alternating spacing of 3" and 2" (7.5 and 5 cm) produces 15 W/ft² (high output), which is best for installations on a concrete slab or when heat loss is a concern.
